### VENDOR APPLICATION Orlando's Kiddies Carnival Saturday May 16th, 2026 at Trotters Park

**ALL VENDORS ARE PROHIBITED FROM SELLING WATER AND ALCOHOLIC BEVERAGES  
VIOLATORS WILL BE CLOSED DOWN AND ESCORTED OUT OF THE PARK BY POLICE DEPARTMENT OR SHERIFF'S OFFICE**

- A. Vendor Space:** **KCOO** will assign vendor space based on the layout of the park.
- B. Refund/Cancellation:** There are **no refunds available**. Vendors that cancel are considered a "no-show" and will forfeit their application fee. **KCOO has no control over the weather and is not obligated to refund fees if the event is affected.**
- C. General Rules:** Vendors must provide/bring their own tents. Each individual space is 10"x10" or no larger than 10"x20". All tents must be stabilized with concrete blocks, sandbags, or any other heavy weights **\*\*NO SPIKES IN THE GROUND\*\***
- D. Water & Alcoholic Beverages:** **No water or alcoholic beverages may be sold on the premises by any Vendor. Water and Alcohol will only be sold by KCOO.**
- E. Waste Disposal:** All food vendors must provide a container to dispose of hot waste. **Hot Oil can not be poured on the grass.** This will cause you to **forfeit your \$100 clean-up fee** and prohibit **KCOO** from using this venue in the future.
- F. Environmental Requirements:** Food vendors **cannot** sell/dispense any products in glass containers. All food waste must be disposed of properly. All trash must be placed in trash containers.
- G. Clean Up:** All vendors must return their space to its original state at the end of the event. A refundable \$100 clean-up fee will be charged with this application. Once the vendor's space is deemed clean the \$100 fee will be returned to the vendor. The **\$100 fee will be forfeited** if the vendor does not clean up their area before leaving the park.
- H. Fire Department Requirements:** All food vendors operating a gas grill, griddle or other flame/grease apparatus must have a fire extinguisher available. The required extinguisher must be a 2A 40BC extinguisher.
- I. Parking:** All vendors must park in the designated vendor parking area. Vendor parking will **close at 12 pm (no exceptions)**. After 12 pm paid general parking will be available, and vendor must walk supplies into the venue.
